## I. Face to Face Committee Sessions

At Olinca's Model United Nations, we encourage delegates to follow certain rules of conduct. These rules include:

- 1. Attend all Committee sessions.
- 2. Remain at the sessions at all times, unless permission to leave is granted.
- 3. Stay in your assigned room. The location of each Committee will be posted.
- 4. Dress in formal/diplomatic attire, as established in the dress code (required for all Committee sessions). The use of inappropriate clothing can be detrimental for the delegate.
- 5. Wear the Committee ID tag at all times.
- Take care of all school facilities.
- 7. Smoking is prohibited during the sessions and in all school premises.
- 8. Unauthorized outfits /costumes and fake weapons are not permitted.

## **II. Online Committee Sessions**

- 1. Delegates must attend all Committee sessions.
- 2. Delegates must remain in the sessions at all times, unless permission to leave is granted.
- 3. The online session links will be given to advisors prior to the debate, and will open 10 minutes before the session starts.
- 4. There will be a tolerance of five minutes to enter the sessions once they have started. After that, all missing delegates will be given a warning.
- 5. Only delegates, Staff and Faculties are allowed in the online session. Faculties must turn off their cameras and microphones.
- 6. Cameras must be on at all times. Failure to comply will result in a warning. If delegates are ever disconnected and unable to join the session, they should inform their advisors to avoid receiving a warning.
- 7. The ID for the online session must only contain the delegation of the participant. Example: Russian Federation.

- 8. The microphone must remain muted, unless the delegate is given the floor.
- 9. Delegates shall exhibit diplomatic behavior at all times.
- 10. Delegates shall use a light, solid color for a virtual background if they choose to use one. No offensive imagery will be on display in the background. Failure to comply will result in a warning.
- 11. Delegates must be seated indoors, on a proper chair, in a formal and single location at all times. Distractors (noise, other people, etc.) should be kept to a minimum.
- 12. Headphones are **recommended** but not mandatory.
- 13. Delegates must connect to the Committee sessions through a computer, an iPad or a tablet, **not** through a cellphone. Cellphones used for other purposes cannot be visible on screen.

## **III. Debate Procedure**

• Delegates must have a physical placard with their delegation's name on it, which they will raise should they want to participate.

NOTE: For online committees where the delegate has been assigned a virtual position, delegates will need to print their own placards. That material will be provided to the advisor.

- Voting for procedures will be done by raising the placard.
- Voting resolutions will be done through roll-call.
- If delegates need to communicate something to the Committee staff related to the debate, they must use the Protocol Points (Point of Order, Point of Personal Privilege, Point of Parliamentary Inquiry).
- If online delegates need to communicate something to the Committee staff that is not related to the debate, use the private chat within the platform. If related to the debate, use the Protocol Points (Point of Order, Point of Personal Privilege, Point of Parliamentary Inquiry).

# IV. Submitting Documents

- Delegates will be asked to hand in a printed copy of their country's position paper, which is intended to state their country's point of view. No plagiarism and misuse of AI are accepted. Copying your position paper will cause a direct warning. Delegates must turn in their Position Papers to their committee's staff before the 1st session.
- Regarding online committees, the delegates will be able to submit their Position Papers prior to the debate. This information will be given to the faculties by email.

## V. Dress Code

Delegates are expected to wear business attire at all sessions. The following guidelines are provided to avoid confusion regarding the expectations:

- Dress code: Business Professional or Business Formal.
- Business casual and casual clothing (T-shirts and sportwear) are unacceptable.
- Revealing outfits are inappropriate for diplomatic work. Low-cut blouses or halters are not acceptable.
- Articles of clothing that reveal undergarments are inappropriate.
- Outfits intended to distract or disrupt the work of Committee sessions, such as costumes which include distracting props, are inappropriate. Fake weapons are not permitted.
- Hats and caps are not permitted in Committee sessions.

# VI. Diplomatic Behavior

During the sessions, delegates will present their nations' points of view regarding different topics in order to come up with a solution that suits all participating countries. Therefore, each delegate should respect these perspectives and act in accordance with the following rules of behavior:

- Show respect to all delegates and participants including Members of the Secretariat, Members of the Committee and Advisors/Faculties.
- Delegates must not insult, bother or mock any other delegate.
- Delegates must not use inappropriate language.
- Delegates must refer to themselves and their fellow delegates in third person at all times during the session.
